**This is the last will** and Ordinance of me John Chyrm of Warbyton Esquire made the  
 25 day of October the year of our lord 1544 and the 24th year of the reign of King Henry  
 the 8th first I will that my first wife margerite my wyf my executrix in my testament named  
 and ordeyned to occupy and take the possession of all my maner lordis and tenementis that I have  
 within the shire of Suffol except the lordis that I have by agret late my wyf and except the maner  
 and manerion of call and the lordis called the dene whighit crall Stohort lord seyson Styllby  
 whyffe long felde manerion by the tenement wythe Amberland Dwellfild Stode morgomland  
 pollerdystroft baron millandit mellehorcham luthoram Glenfeldyt burget wythe the  
 park and the gardeyne adioyning to the said manerion and except all my lond in burghstye  
 and the lordis in warbyton called charge and except also the maner of Crowham and all the  
 lordis and tenementis that I have in the parsh of Westfeld for the tyme of my decess unto  
 the ende and terme of my pore thanne next ensuyng to the tyme that myne executrix with  
 the said wyf and proffyt thereof shall please that my last will as after shall ensue all  
 my will that margerite my wyf shall have the maner and manerion called call and all the said  
 lordis and tenementis called the dene whighit crall Stohort lord seyson Styllby whyffe  
 long felde manerion by the tenement wythe Amberland Dwellfild Stode morgomland  
 pollerdystroft baron millandit mellehorcham luthoram Glenfeldyt burget wythe the  
 park and the gardeyne adioyning to the said manerion for terme of her lyff if she wyll  
 a byde and dwell thereupon and if she wyll nat dwell thereupon thanne I will that my  
 feoffyt shall make to her sufficient grant of a parsh roth of 2 miks by year for the  
 of her lyff out of the said manerion and lordis with a sufficient claufe of distress for  
 lack of payment of the same and thanne myne executrix to receive the residu of the said  
 and proffyt of the said lordis and tenementis called the dene whighit crall Stohort  
 lord seyson Styllby whyffe longfelde manerion by the tenement wythe Amberland  
 Dwellfild Stode morgomland pollerdystroft baron millandit mellehorcham luthoram  
 Glenfeldyt burget wythe the park and the gardeyne adioyning to the said manerion  
 till that my sone willm come to thage of xxij year and thanne my sone feoffyt to make  
 thereof a part to him and to the rest of his body lawfully begoten and for lack of such  
 effect the remynde thereof to thome my sone and to the rest of his body lawfully  
 begoten and for lack of such effect the remynde to Robert my sone and to his heres  
 malit of his body and for default of such heres the remynde to my right heres and  
 all I will that when Thome my sone cometh to thage of xxij year thanne my feoffyt
