William Norris and Elizabeth Patrick

I collected the following information on William Norris (Rev. Sol.) and his wife, Elizabeth Patrick, several years ago while working on my own Norris family in Georgia.I found that I'm not related to these folks, and I am no longer researching this line.However, I'm very happy to share the information below, with the hope that it helps someone else.

WILLIAM NORRIS Rev. Sol.

The following information was taken from a card file at the Georgia State Archives in Atlanta. The information was provided by:(1.)Lona Norris Carroll (Mrs. Henry C.) of Tennille Georgia, member DAR, Nat. No. 190682, Major General Samuel Elbert Chapter and (2.) Christine Carroll Ferguson (Mrs. William H.) of Tennille Georgia, member DAR, Nat. No. 190683, Major General Samuel Elbert Chapter. Please note that the DAR required no proof of lineage at this early date, and they have no records showing the descendants of William Norris. The information was probably given to the Georgia State Archives by these women in the 1920's or 1930's. The card file shows:

- -- William Norris, Rev. Sol. (1760-1842)
- -- wife:Elizabeth Patrick
- -- children known:James, William, Joel, Isaac, Thomas, Sally

The family apparently originated in South Carolina, based upon the birthplace of James, William, Joel, and Isaac shown in later census records.Using this DAR information as a starting point, I believe that we can accurately follow William Norris after his arrival in Georgia.I've found the following records:

1.(Richmond Co. Ga. Deeds, G.355)

Instrument 11 Dec 1798 -- Thomas Walford of Wilkes Co. Ga to William Norris of City of Augusta, sells part of lot 21 fronting on McIntosh Street in the City of Augusta, bounded north by William Belamy, east by late Reuben Coleman, and northwardly and southwardly by Charles Hill and Company, conveyed to Lewis Noicle(?) by Noah

Helsey 27 Oct 1790, and to Thomas Walford by William Spencer, 12 Apr 1793.wit:Holland McTyre, David B. Butler J. P.Deed recorded in Richmond Co. Ga. 13 Sept 1799.

2.William Norris of Capt. Holland McTyiere's District (McTyre) mentioned in The Augusta Chronical newspaper, 30 Nov 1799, p. 1, column 1, legal notice showing he owed property tax.

3.(Richmond Co. Ga. Deeds, K.279)

Instrument 12 April 1804 -- William Norris and Elizabeth his wife of City of Augusta to William Harkness of same, sells part of lot 21 fronting on McIntosh Street in the City of Augusta, description the same as shown in the deed above.Sg. William Norris by signature, Elizabeth Norris by mark.wit. John Kennedy, Andrew HarknessDeed recorded in Richmond Co. Ga. 6 Feb 1807, proved by John Fee by signature recognition.

4.Georgia Land Lotteries 1805 and 1807.

-- William Norris of Richmond Co. drew blank in 1805 Georgia Land Lottery -- William Norris of Richmond Co. drew LL 42, Dist. 18, of Baldwin Co. in 1807 Georgia Land Lottery

(Note:I believe this land is later part of Jones Co. Georgia (see map) but this needs to be verified)

Now, the picture gets a little cloudy about where William Norris went next.He apparently left Richmond Co. in 1807, because his sale deed was proved by "signature recognition" suggesting that he was no longer around.Some people say he went to Montgomery Co. Georgia, which once included all of present-day Emanuel and Johnson Cos.Much more research on this subject is needed.I'll present the following records in chronological order, but I don't really know where he was living until he reappears in Jones Co. Georgia in 1821.

-- Isaac Norris m. Polly Cowart, 25 August 1811, Montgomery Co. Ga. -- Sally Norris m. Benjamin Powell, 21 July 1811, Montgomery Co. Ga. (These marriage records suggest that William Norris and Elizabeth Patrick were living somewhere in the area in 1811).

6.2 Sept 1817 -- Legal Notice published in the Georgia Journal newspaper: "Will be sold on the first Tuesday in October next, at the courthouse in Emanuel County, between the usual hours, the following parcels of land, to wit ... (then follows a lengthy list of foreclosures, including) ...200 ac. of pine land, as the property of William Norris, to satisfy an execution in favor of James Raney; levied on by Samuel Moore, Constable."

Instrument 27 Dec 1827 -- William Norris of Houston Co. to James W. Cannon of same, sells 1/2 of LL 33, Dist. 14 of Houston Co. Georgia.wit:John Green, Daniel Golding, Isaac Norris, Wm. Johnson J.I.C.

(Note:Isaac Norris of Houston Co. also sold land to James W. Cannon on 3 Jan 1828 and lived adjacent to him in the 1830 census.See records for Isaac Norris below)

After this 1827 deed, I found no further records of William Norris Rev. Sol. that we can be certain is the same person. The women that gained membership in the DAR said that William died in 1842. I don't know how they knew that. He may have died in Houston Co. Ga. 1827-1830, or he could have lived somewhere with Sally (Norris) Powell.

THOMAS NORRIS (said to be son of William Norris Rev. Sol.) -- I found no mention of Thomas Norris, but there is one possibility for his widow in Putnam Co. Georgia.See the section on John Norris below.

12.As these records show, there is a long period in the life of Isaac Norris when he owned land in Jones Co. and Houston Co. simultaneously.Isaac seems to move backand-forth between his two tracts, and is just as likely to be shown "of Jones Co." as he is to be shown "of Houston Co."I mention this because there is a completely different Isaac Norris from North Carolina that first appears in adjoining Twiggs Co. about 1850 -- apparently no relation.
