Horne Family Bible 15

The title page shows that the Bible was published in Springfield, Mass. in 1846. A notarized statement on each of the 5 pages was made in Polk County, Florida, April 30, 1964 by Louise Horne Burns stating that this is a true copy of the family records in a Bible in the possession of Mrs. Virginia Hyman of Jasper, Florida.

All the entries prior to 1865 seem to be written by one person at the same time, indicating that they were copied from an older record. A total of six different handwritings are found in the record. Practically every entry gives the birth order and the parents of the person being written about. I have condensed this by identifying parents of each group as they occur.

Births:

Joab Horne, father of A. B. Horne and second son of Abisha and Mary Horne was born 20 Sep 1775. (A marginal note says "Mary was a Ricks")

Nancy Dixon, first daughter of Jesse Dixon and Elizabeth Bell was born 20 Dec 1777

Note: This family was originally in Edgecomb Co. N. C. and then came to the Central Georgia area, mostly to Twiggs, Laurens and Pulaski Counties. Their numerous descendants are widely scattered now, but many of them are still found in Central Georgia.

EVALUATING THE BIBLE RECORD

- 1. Note that the copywrite date is 1846 and the events recorded begin in 1775. This does not necessarily destroy the validity nor the reliability of the evidence.
- 2. Most of the material seems to have been recorded by one person and at the same time, indicating that it was copied from an older record.

- 3. Spacing of births was regular and reasonable.
- 4. The style of handwriting and wording of events recorded is similar to that in use during the middle to late eighteen hundreds.
- 5. Blank spaces on the first and last pages were used to record family events at later dates. This shows the Bible stayed in the family.
- 6. A notarized photocopy of the record pages was made April 30, 1964 by the family member who has the Bible now. Copies were distributed to family members.
- 7. For a good clue to the identity of the person making this record, look at the entry of the death of A B Horne which is the next to last entry on the page where deaths were recorded. I believe Mary H. Horne was recording the death of her husband. More than twenty years had elapsed since the previous entry but the letter formation can easily be seen as the same.

HOW VALUABLE IS THIS RECORD?

- 1. There was no reason for the person recording these events to put down false entries. After all, the purpose in writing this down was to preserve the record of the family as far as birth and death dates were concerned.
- 2. I have personally checked census records for a number of individuals appear in these records and find that the birth years agree in both records.
- 3. I have seen several documents in the possession of family members which agree with this record and have seen sources cited for several others. One of these is the will of Abisha Horne who is mentioned in the first birth recorded. Another is his marriage to Mary Ricks which is recorded with source cited in the History of the Ricks Family, published in 1908.

Using the preponderance of evidence method, I find no reason not to accept this Bible record as an acceptable record of this family. Of course the process of documenting every possible entry should be continued and copies of all documents obtained. This record is a real treasure. I only wish that every family was as fortunate as this one was.

Note: CGGS Quarterly, Vol. 9, No. 2, p. 27 shows that Arthur B. Horne and wife Mary H. Horne joined Sand Ridge Baptist Church in Houston County by letter on May 21, 1848 and that he was chosen to be church clerk on May 26, 1849.

Pace Family Bible 17

Thomas Pace was born about 1745, died about 1850, his wife, Cebelle Matthews, was born about 1763, died about 1850, they were married in 1780. Their children:

William, Nanne, John, Mary, Martha, James, Elizabeth, and Hardy.

Hardy Pace born May 11, 1784, died November 17, 1836, married first Susan Turner on May 20, 1809, she died in 1810. He married second Fannie Hopkins in Hancock County, Georgia, on April 2, 1812. She was born April 27, 1783 in N. C., and died in Twiggs County March 6, 1859.

Children of Hardy Pace and his wife, Fannie Hopkins Pace ¹⁸ were: Thomas, William, Rebecca, James, Cebelle, and Martha Susan.
