Norman, from Flocques, Seine-Maritime, arr. Dieppe, cant. Eu (Loyd, 43), Domesday tenant of the count of Eu in Sussex. One of the canons established at St Mary's, Hastings, by Count Robert, in which post he succeeded his brother Hugh, who must have died before the Domesday Survey (*Suss.Rec. Soc.* xlv, 299–302, record and confirmation by Count Henry of Eu). Geoffrey can be identified partly through an association with Walter fitz Lambert, who endowed Hugh and Geoffrey's prebend.

Goisfrid De La Wirce

Breton, from La Guerche, dépt. Ille-et-Vilaine, tenant-in-chief in several Midland counties in 1086. Younger son of Sylvester, bishop of Rennes, and brother of William, seigneur de La Guerche; see J.-P. Brunterc'h, 'Puissance temporelle et pouvoir diocésain des évêques de Nantes entre 936 et 1049'. *Mém. Soc. d'Histoire et d'Archéologie de Bretagne*, lxi (1984), and J.-C. Meuret, 'Familles seigneuriales aux confins Anjou-Bretagne', *ibid.*, lxx (1993), 91ff. He had married Alfygtha, daughter of his English 'antecessor' Leofric of Nuneham (*Mon. Ang.* vi. (2), 996). There is no trace of him after 1093 in English or Breton documents, though a Herve son of Geoffrey attests charters of La Guerche in 1115 and 1127. This Hervé was perhaps the same as Hervé brother of Stephen, and of Warin, a monk of Marmoutier at Béré (*Arch. dépt. Ille-et-Vilaine IF* 3330, Béré no. 9). Geoffrey's English fief was regranted to Nigel de Albini of Mowbray by Henry I. Keats-Rohan, 'Le rôle des Bretons dans la politique de la colonisation normande', *MSHAB*, lxxiv, 1996, 192–3.

Goisfrid De Magnavilla

Norman, from Manneville, Seine-Maritime, arr. Dieppe, cant. Bacqueville, now in the combined commune of Le Thil-Manneville (Loyd, 57). Important Domesday tenant-in-chief, with lands concentrated in the south-east. Castellan of the Tower

of London. Twice married, to Athelais (Adelais/isa?) and Lescelina, he had several sons, of whom Walter was one of his tenants in 1086; he and Lescelina founded Hurley as a cell of Westminster c.1085. At the same date his daughter Beatrice was the wife of Geoffrey, natural son of Eustache count of Boulogne. He supported the candidature of Robert Curthose as king on the death of William I, but thereafter accepted William II. His eldest son William succeeded him, probably shortly before 1100. See K.S.B. Domesday tenant of Roger Pictaviensis. Probably to be identified with Geoffrey de Ria, (probably named from Ri, Orne, cant. Putanges-Pont-Ecrepin), who was an early benefactor of Roger's priory at Lancaster, a cell of Sées. See K. Norman from Rots, Calvados, arr. Caen, cant. Tilly-sur-Seulles (Loyd, 86). Domesday tenant of Odo of Bayeux in Kent, probably a relative of Ansqetil (q.v.). His successor by 1129 was Geoffrey II de Ros (Sanders, 105).

Domesday tenant of earl Hugh of Chester. Possibly named from Lessard-et-le-Chêne, Calvados, cant. Livarot.
