

**Radulf De Brueria**

Norman, Domesday tenant of Baldwin of Exeter. His successor in 1166 was Antony de Brueria, who held five fees of Robert fitz Roy.

**Radulf De Buceio**

Ralph fitz Landric de Buceio, from Boucé, Orne arr. Argentan (Loyd, 21), tenant of William de Braose in Sussex; attested Braose charters for Sele Priory, a cell of Saint-Florent-de Saumur (CDF 1110, 1112). In another such charter (ibid. 1132) he attested with Leuvinus his 'armiger', perhaps the English tenant of that name who also occurs on the Braose fief in 1086.

**Radulf De Burun**

Norman, from Buron, Calvados. Domesday lord of Horsley, Derbyshire. Apparently dead by 1102. Succeeded by Hugh de Buron, d. 1156 (Sanders, 122-3).

**Radulf De Caisned**

Norman, from Le Quesnay, Seine-Maritime, arr. Neufchâtel, cant. and comm. Saint-Saëns (Loyd, 27-8), Domesday tenant of William de Warenne and others. His wife Matilda predeceased him and he made grants for her soul to Lewes priory. He was succeeded in the early twelfth century by his son William, and eventually by the issue of his son Ralph; father also of Hugh and Sibil, wife of Robert fitz Walter de Caen.

**Radulf De Contevilla**

One of two tenants named Ralph holding of Walter de Douai and the abbot of Glastonbury in 1086, he is identified by Exon Domesday. Probably from one of two Contevilles in Pas-de-Calais, Conteville near Saint-Pol-sur-Ternoise, or Conteville-lès-Boulogne. Winebald of Ballon's grant of Upton to Bermondsey priory (prob. c. 1093-1112) was attested by Ralph de Conteville, his wife Holdiard and their daughters Matilda and Hawise (BL Harley 4757, fol. 7). Richard de Conteville was Glastonbury's tenant in 1189 (Feodary, p. 95).

**Radulf De Creneburne**

Tenant of the abbot of Cranborne in 1086; so named in the Tax Return for Cranborne Hundred. Probably ancestor of Warin of Cranborne (q.v.) who was sheriff of Dorset in 1164.
